5. Confirmation of the Mayor's appointment of a Common Council member for a one-year term to the Plan Commission. (A 2/3 vote of all Council members is required for confirmation)
6. The Mayor will announce his appointments of Common Council members to the standing committees of the Common Council: Finance, Public Works and Public Safety
7. The Mayor will announce his appointments of elected City officials who will serve as voting members to the following Boards and Commissions: Hudson/North Hudson Community Access Board, St. Croix EMS Commission, Hudson Area Joint Library Board, Park Board, Advisory Joint Fire Board (must be a member of the Public Safety Committee), Hudson Urban Forestry Board and Hudson Bicycle and Pedestrian Advisory Committee.
8. The Mayor will announce his appointments of elected City officials to serve as non-voting liaisons to the Hudson School Board, the Hudson Tourism Bureau, the Public Utility Commission and two individuals to the Hudson Area Intergovernmental Advisory Council.
9. Common Council confirmation of the Mayor's appointments of citizen members to the following boards, commissions and committees:
  - A. Zoning Board of Appeals
  - B. Police and Fire Commission
  - C. Advisory Joint Fire Board
  - D. Hudson Housing Authority
  - E. Hudson Area Joint Library
  - F. Hudson Urban Forestry Board
  - G. Plan Commission
  - H. Hudson Bicycle/Pedestrian Committee
