This constitutes a meeting of the City Council pursuant to State ex rel. Badke v. Greendale Village Bd., 173 Wis. 2d 553, 494 N. W. 2d 408 (1993), and must be noticed as such, although the Council will not take any formal action at this meeting.

The meeting was called to order by Chairman Hoggatt at 7:00 p.m.

A motion was made by Webber, seconded by Muller to approve the January 25, 2016 meeting minutes.

Motion carried.

Invitation from Stephen Clark, Bicycle Friendly Community Specialist to visit Hudson on Friday, April 29, 2016 to conduct a bike tour and assess the existing systems and conditions for a bike friendly community. Darnold presented an invitation from Stephen Clark, League of American Bicyclist to conduct a visit to Hudson on Friday, April 29, 2016 to meet with the committee and conduct a five to eight mile ride to assess the city systems and to discuss findings with city officials and other interested parties at the end of the ride. The committee agreed that a visit from Mr. Clark would be very beneficial to the on-going planning efforts. Darnold commented that a route needs to be determined prior to the visit. A motion was made by Webber, seconded by Hoggatt to accept the invitation from Mr. Clark / League of American Bicyclists to conduct the visit in the morning of April 29th. **Motion carried.**

Hoggatt agreed to draft a route of approximately five to eight miles that would be used for the morning tour with Mr. Clark.

St. Croix County Bicycle and Pedestrian Plan- 2016- preliminary recommendations. Darnold reviewed the revised preliminary recommendations of the St. Croix County Bicycle / Pedestrian Plan noting that the recommendations focus on corridors / connections between Stillwater, MN / Houlton, WI; Willow River State Park; and River Falls / town of Troy area to the city's systems. The county recommendations include suggested improvements along the corridors such as off-road pathways, bike lanes, bike routes, minor enhancements, etc. The issue for the city is potential costs of improvements and how the efforts to complete the improvements relative to other jurisdictions occur.

Draft priority corridors-City of Hudson. Hoggatt emphasized providing connections between park and school facilities and provided proposed routes to Darnold to incorporate into the draft corridor map. There were no other corridors proposed or priorities established.

Darnold presented the tentative plans to provide pathways within the proposed Carmichael Ridge planned residential development including connections to the StonePine residential development and Carmichael Road and Coulee Road. The system in the northerly open area will serve as access to the city's trunk sanitary sewer and stormwater systems and as public pathways.

Other business for discussion purposes only or placement on future agendas. Webber noted the Safe Routes to School program and that a meeting was planned for March 1 to discuss a proposed Walk to School program that will be scheduled in May.

A motion was made by Webber, seconded by Huntley to adjourn. **Motion carried.** 7:48 p.m.
