Regulations – Prohibited Practices:

A Direct Seller/Transient Seller or Solicitor shall be prohibited from:

1. Calling at any dwelling or other place between the hours of 8:00 p.m. and 9:00 a.m., except by appointment.
2. Calling at any dwelling or other place where a sign is displayed bearing the words "No Peddlers" or "No solicitors" or words of similar meaning.
3. Calling at the rear door of any dwelling place.
